### Statement

ARTICLES OF INCORPORATION IN SPIRE CHARTER SCHOOL (NON-PROFIT) The undersigned person, pursuant to Section 79-11-137 of the Mississippi Code of 1972 hereby executes the following document and sets forth:

1. The name of the corporation is INSPIRE CHARTER SCHOOL.
2. The period of duration is perpetual.
3. The physical address of its initial registered office is 1820 23rd Street North Columbus, Mississippi, 39701 and the name of its initial registered agent at such address is Tony Montgomery. The mailing address is 1820 23rd Street North, Columbus, MS 39701.
4. The name and complete address of the incorporator is as follows: Tony Montgomery 114 Hunnington Dr Columbus, MS 39705. The incorporator is an adult resident citizen of the State of Mississippi.
5. This corporation is a charitable nonprofit organization within the meaning of Section 79-11-101, et seq. Code of Mississippi of 1972.
6. The purposes for which this corporation is organized are exclusively, scientific, literary, and educational within the meaning of Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future Internal Revenue Service laws.
7. The purpose of this corporation is to provide a formal education for compulsory school aged children and improve the quality of life for people residing in Columbus, Mississippi and the surrounding areas. The INSPIRE Charter Schools Mission is to provide a high quality education that puts students first and prepares them to become COLLEGE READY SCHOLARS and life-long learners.

In the event of the dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(C)(3) of the Internal Revenue code of 1986 or corresponding sections of any prior or future Internal Revenue code, or to the federal, State or local government for exclusive public purposes.
9. No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.
